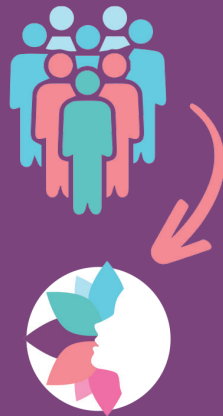

"Vision Builders" is a committed group of donors coming together to provide resources for the Crisis Center of Anderson and Cherokee Counties.



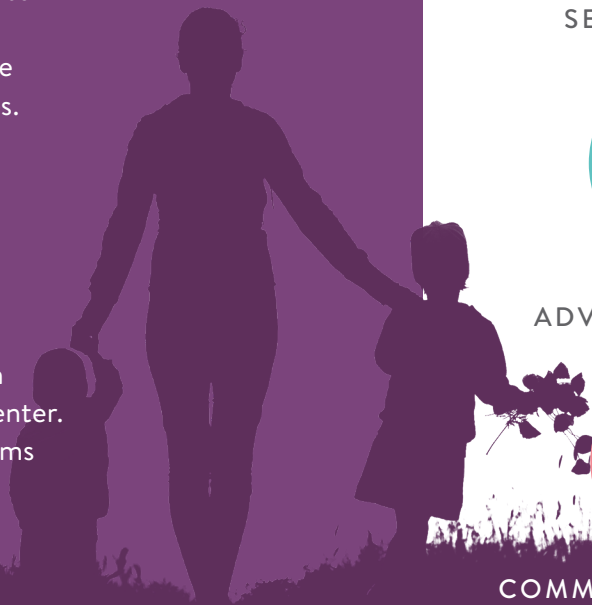
WHY WE NEED YOUR HELP
